3. Role of Dogoolle Ltd

Dogoolle Ltd acts as a technical service provider through its platform *voteforme.click*. It provides a secure space for managing public votes and messages. **The organization of the contest, its rules, legal management, and the appointment of winners are the sole responsibility of the contest organizer**, identified upon creation of their personal space.

4. Data Collected

To ensure the proper functioning of contests, we collect the following data:

From voters:

- Date of vote
- Email address
- Name provided
- Amount paid
- Message sent to the contestant

From contestants:

- Email address
- Additional data depending on the contest (e.g., nationality, height, category)

This data is used solely to:

- Ensure the proper conduct of the contest
- Display results
- Provide access to messages sent to contestants
- Identify winners if necessary

5. Payments & Banking Data

Payments are processed directly through our partners **Stripe** and **Mollie**. We do not store or access any banking data (card numbers, IBAN, etc.). For more information, please refer to [Stripe's Privacy Policy](#) and Mollie's Privacy Policy.

6. Data Retention Period

Data is retained for a maximum of **12 months** after the end of the contest, unless a legal obligation requires otherwise.

7. Legal Basis for Processing

Your data is processed based on:

- Performance of a contract (contest management)
- Legitimate interest (security, statistics)
- Consent, when required (e.g., sending messages or newsletters)

8. Your Rights

In accordance with the General Data Protection Regulation (GDPR), you have the following rights:

- Right of access
- Right to rectification
- Right to erasure
- Right to restriction of processing
- Right to object
- Right to data portability
